- **The Arts & Craft Show is located in Annrook Park along the sidewalk by the river.** It is strategically located between the main parking for the event and the Skerbeck Family Carnival.
- Crafters must provide their own tent, tie downs, tables and chairs.
- Vendors will be allowed to set up on Thursday, August 19th from 6:00 pm to 10:00 pm. Friday morning all Crafter vehicles must be moved to legal parking areas no later than 9:00 am. You must be set up and ready to open for business by 10:00 am Friday. You must participate in **all three days** of the show.
- **NO ELECTRICITY WILL BE PROVIDED.**
- Parking will be available in the park for ease of loading and unloading your merchandise. Parking is on a first come first serve basis for everyone coming to the festival (vendors and public). Parking is only allowed in legal parking spaces.
- No overnight camping is allowed in the park.

	Saturday, August 21	10am - 9pm
	Sunday, August 22	10am - 5pm

NO REFUNDS will be given for cancellations.

Applications should be submitted with a photo for each item you would like to sell at this event. (Photos will not be returned). A “clear” photo of your booth displaying your craft is acceptable in most cases. You can return your application by email with your photos as an attachment. The Arts & Crafts Committee will jury the candidates and make their selections upon receipt of forms. All applicants will be notified of the committee’s decision and those selected will receive a rental agreement form. **Do not send money until you receive confirmation of acceptance and a rental agreement!** Send applications to: 108 W.
