Dear Crafter,

We are delighted to provide you with an application for the **Arts & Craft Show** at the **2022 Lapeer Days Summer Festival**. This festival is Lapeer County's premier summer event which annually draws thousands of people to the streets of downtown Lapeer over the weekend.

Please take note, a minimum of **80%** of the items in your booth must be hand-made or home-made.
NO EXCEPTIONS!!

- **The Arts & Craft Show is located in Annrook Park along the sidewalk by the river.** It is strategically located between the main parking for the event and the Skerbeck Family Carnival. See attached map.
- Crafters must provide their own tent, tie downs, tables and chairs and any equipment needed.
- Exhibitors are responsible for their own insurance.
- Vendors will leave the condition of the premises as found. Damages to any property will be paid for by the vendor.
- No lighting or electricity is provided. Absolutely **NO GENERATORS ALLOWED.**
- Vendors will be allowed to set up on **Thursday August 18th from 6pm to 10pm.** Friday morning all Crafter vehicles must be moved to legal parking areas no later than 9am.
- You must be set up and ready to open for business by 11:00 am Friday. **You must participate in all three days of the show.**
- **Friday, August 19, 11am-8pm – Saturday, August 20, 11am-8pm & Sunday August 21, 11am-5pm**
- Parking will be available in the park for ease of loading and unloading. Parking is on a first come first serve basis for vendors and the general public. Parking is only allowed in legal parking spaces.
- No overnight camping is allowed in the park.
- **The indemnification Agreement MUST BE RETURNED WITH YOUR APPLICATION.**
- **All rights reserved by the Lapeer Days Festival Committee. Submission of application is not a guarantee of acceptance to the show.**

NO REFUNDS will be given for cancellations.

Applications should be submitted with a photo for each item you would like to sell at this event. Photos will not be returned. You can return your application by email with your photos as an attachment. **Do not send money until you receive confirmation of acceptance! Space is limited so don't delay!!**
